### INVITATION FOR NEGOTIATED PROCUREMENT FOR THE “Design and Build of Infrastructure Project for the Repair of ITDI Buildings – CED Energy Pilot Plant for the Establishment of Fuel Cell R&D and Testing Facility of CED ITDI-DOST”

1. In view of the two (2) failed public biddings pursuant to **Section 53.1 of the Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act.”**, the Industrial Technology Development Institute (ITDI) Bids and Awards Committee (BAC) invites interested bidders to participate in the negotiation for the **“Design and Build of Infrastructure Project for the Repair of ITDI Buildings – CED Energy Pilot Plant for the Establishment of Fuel Cell R&D and Testing Facility of CED ITDI-DOST”** with a total Approved Budget for the Contract (ABC) of Eleven Million Five Hundred Thousand Pesos (P11,500,000.00).

**All other particulars relative to this negotiation shall be governed by the provision of the above-mentioned Act.**

A complete set of **Negotiated Procurement Documents (NPD)** may be acquired by the interested Bidders starting **July 30, 2021 to August 17, 2021 from 8:00AM to 4:00PM** at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable, nonrefundable fee in the amount of **FIFTEEN THOUSAND PESOS (PHP 15,000.00)** pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the ITDI website, provided further that those, who is/are interested to participate in the negotiated procurement, shall pay the cost of the **NPD** on or before the submission of their proposals.

The ITDI-BAC will hold a **Negotiation Conference on August 5, 2021, 9:00 A.M.** via Zoom. Bidders will be required to submit a **Letter of Intent (LOI)** to join the Negotiation Conference through email address **admbac@itdi.dost.gov.ph**. The link will then be sent only to those interested bidders who submitted their LOI.

2. The submission of eligibility and technical documents as well as the Financial Proposal Form shall be on **August 17, 2021, between 8:30 – 9:00 AM** at the **Metrology Conference Room, Metrology Building, DOST Compound, Bicutan, Taguig City.**
3. Opening of the eligibility documents, technical documents and financial proposal will be on **August 17, 2021, 9:01 A.M. at the Metrology Conference Room, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan, Taguig City.**

All bidders are requested to observe the following during the submission and opening of bids:

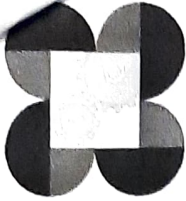
- a. Only one (1) representative from each company shall be allowed to participate in the bidding;

- b. Opening of bids will be done per project. Only representative participating in that project will be allowed to enter the conference room;
  - c. Bidders will be given a designated waiting area;
  - d. Maximum of ten (10) persons will be allowed to stay inside the conference room;
  - e. Representatives shall be required to wear face mask and face shield or any protective gear at all times;
  - f. Social/Physical distancing maintaining at least one (1) meter apart.
4. **INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI)** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
5. The Bidders shall submit **three (3) copies** of their duly accomplished eligibility requirements, Technical and Financial Proposal into one **(1) sealed envelope**.
6. The ITDI reserves the right to reject any and all bids, declare a failure of bidding, and not to award the contract if 1.) there is a prima facie evidence of collusion between appropriate public officers or employee, or between the BAC and any of the bidders themselves, or between the bidders and a third party, including any act which restricts, suppresses, or nullifies or tends to restrict, suppress or nullify competition; 2.) the BAC is found to have failed in the prescribed bidding procedures; or 3) for any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the government as defined in the IRR.
