



## INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The **Industrial Technology Development Institute**, through the **GIA Project “Integration of Testing Services for Rubber and Rubber-Based Products, Year 3”** intends to apply the sum of One Million Five Hundred Ninety Pesos only (**Php 1,590,000.00**) being the Approved Budget for the Contract (ABC) to payments under the contract for **one (1) unit Flammability Tester**.

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The **Industrial Technology Development Institute (ITDI)** now invites bids for **one (1) unit Flammability Tester with Ninety (90) Calendar Days** delivery period.
3. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project as provided for in Section 23.5.1.3 of the IRR of RA 9184. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg. starting October 28, 2016 from 8:00AM – 4:00PM**. Interested bidder is required to submit Letter of Intent to participate in the bidding.
7. A complete set of Bidding Documents may be acquired by interested Bidders from the ITDI BAC Secretariat, Second Floor Metrology Bldg. upon payment of a non-refundable fee of **Three Thousand Pesos (P3,000.00)**.
8. The ITDI-BAC will hold a **Pre-Bid Conference on November 4, 2016 at 9:00 A.M** at the **Metrology Conference Room, 2<sup>nd</sup> Floor ITDI Metrology Building, DOST Compound Gen. Santos Ave. Bicutan, Taguig City**, which shall be opened only to all interested parties who have purchased the Bidding Documents.
9. Bid submission shall be on **November 16, 2016 between 10:00AM to 10:30AM** at the **Metrology Conference Room, 2<sup>nd</sup> Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City** with the following Schedule:
10. Bid opening shall be on **November 16, 2016, 10:30 A.M.** at the **Metrology Conference Room, 2<sup>nd</sup> Floor, ITDI, Metrology Building, Bicutan, Taguig City**. Bids will be opened in the presence of the Bidders’ representatives who choose to attend.
