



## INVITATION TO BID FOR INFORMATION & COMMUNICATION TECHNOLOGY EQUIPMENT

1. The **Industrial Technology Development Institute**, through General Appropriations Acts (GAA) intends to apply the sum of Three Million Three Hundred Forty Seven Thousand Pesos (**Php 3,347,000.00**) being the Approved Budget for the Contract (ABC) to payments of **one (1) Lot Maintenance and Installation of New fiber optic Cables in ITDI Compound.**

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The **Industrial Technology Development Institute (ITDI)** now invites bids for **one (1) lot Maintenance and Installation of New Fiber Optic Cables in ITDI Compound with Ninety (90) Calendar Days Project Duration.**
3. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project as provided for in Section 23.5.1.3 of the IRR of RA 9184. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg. starting September 7, 2016.** Interested bidder is required to submit Letter of Intent to participate in the bidding.
7. A complete set of Bidding Documents may be acquired by interested Bidders from the ITDI BAC Secretariat, Second Floor Metrology Bldg. upon payment of a non refundable fee of **Five Thousand Pesos (P5,000.00).**
8. The ITDI-BAC will hold a **Pre-Bid Conference on September 12, 2016 at 9:00 A.M** at the **Conference Room, Second Floor, ITDI Metrology Building, DOST Compound Gen. Santos Ave. Bicutan, Taguig City**, which shall be opened only to all interested parties who have purchased the Bidding Documents.
9. Bids must be delivered on **September 26, 2016 between 8:30 A.M to 9:00 A.M at the Conference Room, Second Floor, ITDI Metrology Building, DOST Compound, Bicutan, Taguig City.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18 plus a **Bid Securing Declaration.** Bids submitted after 9:00 A.M. on September 26, 2016 shall not be accepted.
