

INVITATION TO BID FOR INFORMATION & COMMUNICATION TECHNOLOGY EQUIPMENT

1. The Industrial Technology Development Institute, through GIA Project "Setting-up of One-Stop Laboratory Services for Global Competitiveness (OneLab)" (Equipment Outlay) intends to apply the sum of Ten Million Pesos (Php 10,000,000.00) being the Approved Budget for the Contract (ABC) to payments of the following:

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Santos Ave. Bicutan, Taguig City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18 plus a **Bid Securing Declaration**. Bids submitted after 9:30 A.M. on August 30, 2016 shall not be accepted.
10. Bid opening shall be on **August 30, 2016, 9:30 A.M.** at the **Almanzor Hall (formerly Training Room), Lower Ground Floor, ITDI Metrology Building, DOST Compound Gen. Santos Ave. Bicutan, Taguig City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend.
