INVITATION FOR NEGOTIATED PROCUREMENT

REPAIR /RENOVATION AND MAINTENANCE OF ITDI BUILDINGS

In view of the two (2) failed biddings, Industrial Technology Development Institute, through Bids and Awards Committee invite suppliers to participate in the negotiation for the Project "Repair/Renovation and Maintenance of ITDI Buildings and Facilities" in accordance with Section 53.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" with an Approved Budget for the Contract (ABC) of **Seven Million Four Hundred Thousand Pesos (Php 7,400,000.00)** to payments under the contract for the "Supply and Delivery of Labor and Materials for the Repair/Renovation and Maintenance of ITDI Buildings. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI)** now invites bids for the above-mentioned project. Location is at ITDI-DOST Compound Gen. Santos Ave., Bicutan, Taguig City. Completion of the Works is required within **Ninety (90) calendar days**.

Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Seven Thousand Pesos (Php 7,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than submission of their offers.

The ITDI-BAC will hold a Pre-Negotiation Conference on **December 22, 2017, 1:30 P.M.**, Metrology Conference Room, 2nd Floor ITDI Metrology Building, DOST Compound, Bicutan, Taguig City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids must be delivered to the address below on **December 27, 2017, 9:30 am. at the Metrology Conference Room**, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan, Taguig City.

Bid opening shall be on **December 27, 2017, 10:00 am.** at the Metrology Conference Room, 2nd Floor ITDI Metrology Building, DOST Compound Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.

The Bidders shall submit **three (3) copies** of their duly accomplished eligibility requirements, Technical and Financial Proposal into **two (2) separate sealed envelopes**.
