

## INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The **Industrial Technology Development Institute**, through **General Appropriations Act (GAA) Locally Funded Project "Enhancement of the Competence and Capabilities of the National Metrology Laboratory of the Philippines – Project 4: Strengthening the Physical Metrology Capabilities of the National Metrology Laboratory"** – FY 2017 intends to apply the sum of **Fourteen Million Seven Hundred Fifty Thousand Pesos (P14,750,000.00)** only being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The **Industrial Technology Development Institute (ITDI)** now invites bids for the above-mentioned equipment. Delivery of the Goods is required within **Ninety (90) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg.** starting **July 21, 2017 from 8:00AM – 4:00PM**.



Bids must be duly received by ITDI-BAC Secretariat at the **Metrology Conference Room, 2<sup>nd</sup> Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City** on **August 10, 2017** between **8:30 AM – 8:45 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**:
8. Bid opening shall be on **August 10, 2017** and shall start at **9:00 A.M.** at the **Metrology Conference Room, 2<sup>nd</sup> Floor, ITDI, Metrology Building, Bicutan, Taguig City**. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
