

INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The **Industrial Technology Development Institute**, through **General Appropriations Act (GAA)** intends to apply the sum of intends to apply the sum of Three Million Pesos only (**Php 3,000,000.00**) being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

2)	1 unit	Pick-up	1,400,000.00

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The **Industrial Technology Development Institute (ITDI)** now invites bids for **one (1) unit Passenger Van and One (1) unit Pick-up**. Delivery of the Goods is required within **Thirty (30) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg. starting June 22, 2017 from 8:00AM – 4:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders until **July 13, 2017** from the ITDI BAC Secretariat, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of as follows:

8. Bid opening shall be on **July 13, 2017** and shall start at **10:00 A.M.** at the **Metrology Conference Room, 2nd Floor, ITDI, Metrology Building, Bicutan, Taguig City.** Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
