

INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The Industrial Technology Development Institute, through GIA Project "Development, Characterization and Performance Evaluation of Polymeric Separation Membrane for Industrial Applications using Local Materials" – FY 2017 intends to apply the sum of Fourteen Million Four Hundred Fifty Thousand Pesos only (Php 14,450,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The Industrial Technology Development Institute (ITDI) now invites bids for one (1) lot Hollow Fiber Membrane and Module Fabrication Equipment, one (1) lot Capillary Flow Porometer and one (1) lot Casting Machine. Delivery of the Goods is required within **Ninety (90) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg. starting March 20, 2017 from 8:00AM – 4:00PM.**
5. 

8. Bid opening shall be on **April 10, 2017** and shall start at **1:00 P.M.** at the **Metrology Conference Room, 2nd Floor, ITDI, Metrology Building, Bicutan, Taguig City.** Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
