## INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The Industrial Technology Development Institute, through the Program "Enhancement of the Competence and Capabilities of the National Metrology Laboratory of the Philippines - Project 4: Strengthening the Physical Metrology Capabilities of the National Metrology Laboratory" intends to apply the sum of Thirty Nine Million Eight Hundred Forty Thousand Pesos (P39,840,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

- 2. The Industrial Technology Development Institute (ITDI) now invites bids for abovementioned equipment. Delivery of the Goods is required within Ninety (90) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with (i) at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting July 17, 2020 from 8:00AM - 4:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from July 17, 2020 until August 5, 2020 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount as follows:

  admbac@itdi.dost.gov.ph. The link/invitation will then be sent to those interested bidders who submitted
  LOI.
- 7. Bids must be duly received by ITDI-BAC Secretariat at the Metrology Conference Room, 2<sup>nd</sup> Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City on August 5, 2020 between 8:00 AM 9:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18:
- Bid opening shall be on August 5, 2020 and will start at 9:00 A.M. at the Metrology Conference Room, 2<sup>nd</sup> Floor, ITDI, Metrology Building, Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

All bidders are requested to observe the following during the submission and opening of bids:

- Only one (1) representative from each company shall be allowed to participate in the bidding;
- Opening of bids will be done per item. Only representative participating in that item will be allowed to enter the conference room;
- Bidders will be given a designated waiting area;
- Maximum of ten (10) persons will be allowed to stay inside the conference room;
- Representatives shall be required to wear face mask and/or face shield or any protective gear at all times;
- Social/Physical distancing maintaining at least one (1) meter apart.
- The Industrial Technology Development Institute (ITDI) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
