INVITATION TO BID FOR LABORATORY EQUIPMENT

- 1. The Industrial Technology Development Institute, through "Green Oil and Phytochemicals from Cashew under the auspices of the DOST-MOST China Joint Research Program (RDA-CED-2021-02)" intends to apply the amount of Five Million Nine Hundred Thousand Pesos (Php 5,900,000.00) only being the Approved Budget for the Contract (ABC) to payment for the "Supply, Delivery, Labor, Installation and Commissioning of One (1) set Laboratory Scale Supercritical Fluid Extractor".
- 2. The Industrial Technology Development Institute (ITDI) now invites bids for the abovementioned equipment. Delivery of the Goods is required within Ninety (90) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting August 1, 2022 from 8:00AM – 4:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from August 1, 2022 until August 22, 2022 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents amounting to Ten Thousand Pesos (P 10,000.00), pursuant to the latest Guidelines issued by the GPPB.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The ITDI-BAC will hold a Pre-Bid Conference on August 9, 2022, 9:00 A.M at the Metrology Conference Room, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City.
- 7. Bids must be duly received by ITDI-BAC Secretariat at the Metrology Conference Room, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City on August 22, 2022 between 8:30 AM 9:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

- 8. Bid opening shall be on August 22, 2022 and will start at 9:01 A.M. at the Metrology ConferenceRoom, 2nd Floor, ITDI, Metrology Building, Bicutan, Taguig City. Bids will be opened in thepresence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
