## INVITATION TO BID

"Repair and Renovation of DOST-ITDI KM (Knowledge Management) Platform for STI (Science, Technology and Innovation), Culture and Arts (DOST-ITDI KM-STICA)"

- The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE, through "Capital Outlay 2023" intends to apply the amount of Fifteen Million Pesos (P 15,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the "Repair and Renovation of DOST-ITDI KM (Knowledge Management) Platform for STI (Science, Technology and Innovation), Culture and Arts (DOST-ITDI KM-STICA)". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) now invites bids for the "Repair and Renovation of DOST-ITDI KM (Knowledge Management) Platform for STI (Science, Technology and Innovation), Culture and Arts (DOST-ITDI KM-STICA)". Location is at ITDI-DOST Compound Gen. Santos Bicutan, Taguig. Completion of work is required in One Hundred Twenty (120) calendar days upon issuance of Notice to Proceed.
- Bidders should have completed, within five (5) years from the date of submissionand receipt of bids, a contract similar to the Project. The description of an eligiblebidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules andRegulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 6. A complete set of Bidding Documents may be acquired by interested Bidders from November 15, 2022 until December 5, 2022 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Thousand Pesos (P 20,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- Bids must be delivered on December 5, 2022 between 1:00 PM to 1:30 PM at the Metrology Conference Room, 2<sup>nd</sup> Floor, ITDI, Metrology Building, Bicutan, Taguig City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause18.
- 9. Bid opening shall be on *December 5, 2022*, and will start at 1:31 PM at the MIC Conference Room, 4th Floor ITDI Metrology Building, DOST Compound Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend. Bids submitted after 1:31 PM. on December 5, 2022 shall not be accepted.

All bidders are requested to observe the following during the submission and opening of bids:

- Only one (1) representative from each company shall be allowed to participate in the bidding;
- Opening of bids will be done per project. Only representative participating in that project will be allowed to enter the conference room;
- Bidders will be given a designated waiting area;
- Maximum of ten (10) persons will be allowed to stay inside the conference room;
- Representatives shall be required to wear face mask and face shield or any protective gear at all times;
- Social/Physical distancing maintaining at least one (1) meter apart.
- 10. The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) reserves the right to accept or reject any bid, to annul the bidding process, andto reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
- The Bidders shall submit three (3) copies of their duly accomplished eligibility requirements, Technical and Financial Proposal into one (1) sealed envelope.
- 12. The participating bidders/contractors should have completed similar project ofat least 50% of the ABC, and have the key personnel and equipment, (listed in the eligibility forms) available for the prosecution of the contract. The BAC will use non-discretionary pass and fail criteria in the eligibility
