INVITATION TO BID FOR LABORATORY EQUIPMENT

- 1. The Industrial Technology Development Institute, through "VIP Project 1: Isolation and Purification of Philippine Common Viruses with Medical Importance and Pandemic Potential for Antigen-Antibody Studies" intends to apply the amount of Forty-Seven Million Pesos (Php 47,000,000.00) only being the Approved Budget for the Contract (ABC) to payment for the "Supply, Delivery, Installation and Commissioning of One (1) unit MALDI-TOF-MS (Matrix-Assisted Laser Desorption Ionization - Time of Flight Mass Spectroscopy)".
- 2. The Industrial Technology Development Institute (ITDI) now invites bids for the above-mentioned equipment. Delivery of the Goods is required within One Hundred Twenty (120) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or (i) organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country thelaws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting March 10, 2023 from 8:00AM - 5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from March 10, 2023 until April 3, 2023 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents amounting to Twenty Five Thousand Pesos (P 25,000.00), pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable feefor the Bidding Documents not later than the submission of their bids.

- 6. The ITDI-BAC will hold a Pre-Bid Conference on March 20, 2023, 1:30 P.M at the Metrology Conference Room, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan TaguigCity.
- 7. Bids must be duly received by ITDI-BAC Secretariat at the Metrology Conference Room, 2nd Floor, ITDI Metrology Building, DOST Compound Bicutan Taguig City on April 3, 2023 between 8:30 AM - 9:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
