INVITATION TO BID FOR LABORATORY EQUIPMENT

- The Industrial Technology Development Institute, through "Smarter OneLab for Industry 4.0 through Testing and Calibration, Education and Discovery (ONELAB for TED) – Equipment Outlay" intends to apply the amount of Twenty Million Pesos (Php 20,000,000.00) only being the Approved Budget for the Contract (ABC) to payment for the "Supply, Delivery, Installation and Commissioning of One (1) unit Inhalation Exposure Equipment/System (with complete accessories)".
- 2. The Industrial Technology Development Institute (ITDI) now invites bids for the above-mentioned equipment. Delivery of the Goods is required within One Hundred Twenty (120) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country thelaws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting June 7, 2023 from 8:00AM 5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from June 7, 2023 until June 27, 2023 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents amounting to Twenty Thousand Pesos (P 20,000.00), pursuant to the latest Guidelines issued by the GPPB.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable feefor the Bidding Documents not later than the submission of their bids.
- 6. The ITDI-BAC will hold a Pre-Bid Conference on June 15, 2023, 9:00 A.M. at the Metrology Conference Room, 2nd Floor, ITDI Metrology Building, DOST Compound Bicutan Taguig City.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

- 8. Bid opening shall be on June 27, 2023 and will start at 9:01 A.M. at the Metrology Conference Room, 2nd Floor, ITDI, Metrology Building, Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
- 9. All bidders are requested to observe the following during the pre-bid and opening of bids: a. Only one (1) representative from each company shall be allowed to participate in the
