

REQUEST FOR EXPRESSION OF INTEREST

REPAIR/RENOVATION OF ITDI BUILDINGS: CONSULTING SERVICES FOR ELECTRICAL ASSESSMENT AND DESIGN FOR UPGRADING OF THE ELECTRICAL SYSTEMS OF THE FOOD PROCESSING DIVISION (FPD), MATERIAL SCIENCE DIVISION (MSD) AND PHARMACEUTICALS BUILDINGS

1. The *Industrial Technology Development Institute (ITDI)* through the *ITDI Infra Project 2023* intends to apply the sum of *Three Million Six Hundred Thousand Pesos (P 3,600,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Consulting Services for the Electrical Assessment and Design for Upgrading of Electrical System of the Food Processing Division (FPD), Material Science Division (MSD) and Pharmaceuticals Buildings*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Industrial Technology Development Institute* now calls for the submission of eligibility documents for the *Consulting Services for the Electrical Assessment and Design for Upgrading of Electrical System of the Food Processing Division (FPD), Material Science Division (MSD) and Pharmaceuticals Buildings*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **January 11, 2024, 9:00 A.M at the Metrology Conference Room, 2nd Floor, Metrology Building, DOST Compound Bicutan Taguig City**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from *ITDI BAC Secretariat* and inspect the Bidding Documents at the address given below during **Monday to Thursday, from 7:00 A.M to 6:00 P.M.**
4. A complete set of Bidding Documents may be acquired by interested Bidders on **January 3, 2024** from the address below *ITDI Metrology Conference Room, 2nd Floor, Metrology Building* and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00)**

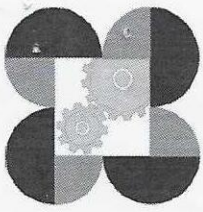
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of *Three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- a) Applicable experience of the Consultant and members in case of joint ventures considering both the overall experience of the firm or, in the case of new firms, the individual experience of the principal key staff, including the times when employed by other consultants.
 - b) Qualification of the personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking, and
 - c) Current workload relative to capacity
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184. In Addition, bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
 7. The Procuring Entity shall evaluate bids using the **Quality-Cost Based Evaluation/Selection (QCBE/QCBS)** procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
 8. The contract shall be completed within **One Hundred Twenty (120) Calendar Days**.
 9. The **Industrial Technology Development Institute (ITDI)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
