



INVITATION TO BID FOR LABORATORY EQUIPMENT (EARLY PROCUREMENT ACTIVITY)

1. The **Industrial Technology Development Institute**, through “**ITDI GAA-Capital Outlay 2025**” intends to apply the amount of **Six Million Pesos (Php 6,000,000.00)** only being the Approved Budget for the Contract (ABC) to payment for the “**Supply, Delivery, Installation and Commissioning of One (1) lot Redundancy of Existing Palo Alto Firewall PA-3220 for high availability, server capability (Upgraded model PA-3420)**”.
2. The **Industrial Technology Development Institute (ITDI)** now invites bids for the above-mentioned equipment. Delivery of the Goods is required within **Forty-Five (45) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg.** starting **November 11, 2024 from 8:00AM – 4:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **November 11, 2024 until December 3, 2024** at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents amounting to **Ten Thousand Pesos (P 10,000.00)**, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The ITDI-BAC will hold a **Pre-Bid Conference on November 18, 2024, 9:00 A.M.** at the **Metrology Conference Room, 2nd Floor, ITDI Metrology Building, DOST Compound Bicutan Taguig City**.
