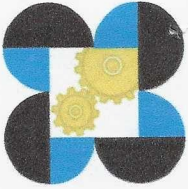
In this regard, you are hereby requested to accept the award and submit the following within ten (10) days from receipt of this notice.

c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security	Thirty percent (30%)
