KNOW ALL MEN BY THESE PRESENT

THIS AGREEMENT, made this ____ day _____ 2022 between the **Industrial Technology Development Institute (ITDI)** of the Department of Science and Technology (DOST), DOST Compound, Gen. Santos Ave., Bicutan, Taguig City, hereinafter called the “**Entity**” and,

Incore Builders & Development from #713 Magiting St., Riverside II, Cainta, Rizal, Philippines hereinafter called the “**Contractor**” was recommended and was resolved to be awarded this contract to the above-mentioned contractor being the winning bidder as per **RESOLUTION NO. 2022-INFRA-WB-06**;

WHEREAS, the Entity is desirous that the Contractor executes the Supply and Delivery of Labor and Materials for the **Repair/Renovation of ITDI Buildings: Upgrading of ITDI – Materials Science Division Nanotechnology Laboratory** through the Capital Outlay FY 2022, hereinafter called “the Works” and the Entity has accepted the Bid for **One Million Six Hundred Ninety-Nine Thousand Nine Hundred Ninety-Five Pesos (Php1,699,995.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bidders;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;

- (h) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the **Entity** to the **Contractor** as hereinafter mentioned, the **Contractor** hereby covenants with the **Entity** to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects;
 4. The **Entity** hereby covenants to pay the **Contractor** in consideration of the execution and completion of the Works with the duration of **Ninety (90) calendar days** and the remedying of defects wherein, the Contract Price of **One Million Six Hundred Ninety-Nine Thousand Nine Hundred Ninety-Five Pesos (Php1,699,995.00)** or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


